I am delighted to present my first APEN President's Report for the 2020/2021 year.

The year was like no other as the world continued to face the challenges of the COVID-19 global pandemic. Despite the headwinds that faced the organisation, we

rallied to deliver programs of value to our members whilst maintaining the organisation's health. I am proud of what we have achieved, which is a testament to the sheer grit and determination from my fellow Board Directors, Regional Coordinators and those who have volunteered on committees or otherwise. The Board controlled the budget expenditure and identified measures to mitigate expenses whilst not compromising our services to members. A key consideration was succession planning for Roe, who will be retiring in early 2022. The Board identified The Association Specialists following an open and transparent expression of interest process, which will support the Board following Roe's retirement. The APEN Board is blessed to have Pat Hamilton serve not only as a director but as Editor of ExtensionNet. Working alongside Pat in the editorial team is Chrissy Stokes, Adrian Englefield, Morag Anderson, and Roe Currie. They together ensure we hit the right note with contemporary and topical content that challenges our readers and supports our members. In addition, APENS Stakeholder Engagement Committee continued to drive our social and digital communication channels and oversee the delivery of professional development webinars and the well-respected APEN mentoring program.

During the year, the Board also commenced planning the 2022 APEN International Conference. Following an Expression of Interest, Professor Ruth Nettle was identified as the Conference Convenor, with the event scheduled for February 9-11, 2022. The conference will be a hybrid event, and I'd encourage you to consider attending the event. More details can be found here https://www.apenconference.com.au.

I have enjoyed seeing APEN grow and challenge itself during my first term as President. I look forward to the ongoing change APEN will experience in the year ahead and further progressing and advocating the extension profession. 2021 APEN Treasurer's Report



This report is based on the completed audit of the Australia-Pacific Extension Network Limited (APEN) finances conducted by Bob Travers & Associates, Chartered Accountant, Albury, NSW.

APEN Ltd is in a positive financial position with a retained surplus of \$100,913 on 30th June 2020. The assets are primarily cash at bank with a small amount of receivables. This result has seen a reduction of \$15,658 in APEN's retained surplus from June 2020 which was \$116,571.

For the 2021 financial year APEN's total income was \$49,799 whilst our expenses were \$65,015 which is directly reflected in our retained surplus. Our income was dominated by \$38,603 from membership payments which was a very positive improvement from \$31,079 in 2020. The other major income item was over \$8,000 from the very successful ExtensionChat 2020.

The financial result is in line with APEN biennial financial cycle, where in conference years, the retained surplus rises significantly and then declines in non-conference years. Obviously, along with the rest of the world APEN has been impacted by Covid 19 with the planned 2021 conference postponed to February 2022. The challenge and reality are that APEN's financial sustainability in highly dependant on a positive financial result from our biennial conference. For the past three years the APEN Board has been exploring options to both better support members professional development and generate additional income with the 2020 ExtensionChat an example and ExtensionChat 2021 planned for November.

The Directors of the registered entity (APEN Ltd.) declare that, in the Directors' opinion:

1. The financial statements and notes, as set out on schedules 1 to 3 (APEN Financial Statements on 30 June 2021), are in accordance with the *Australian Charities and Not-for-profits Commission Act 2012* and:

a) comply with Australian Accounting Standards; and

b) give a true and fair view of the financial position of the registered entity at 30 June 2021 and of its performance for the year ended on that date.

2. There are reasonable grounds to believe that the registered entity will be able to pay its debts as and when they become due and payable.

This declaration is provided in accordance with subs 60.15(2) of the Australian Charities and Not-for-profits Commission Regulation 2013.

As Treasurer, I would like to take this opportunity to thank my fellow APEN Board members who all invest significant time and effort into the effective management and delivery of APEN services. Finally, I would like to offer my true appreciation and thanks to Dr Roe Currie for her excellent work as Company Secretary, management of financial transactions and record keeping. Roe is knowledge central when it comes to all matters APEN and through her efforts contributes immeasurable to the ongoing success of APEN.

APEN Company Secretary's Report 2020 – 2021

This is the fourth Annual General Meeting of APEN Ltd since we moved from an Incorporated Association to a Company Limited by Guarantee on 16 November, 2017.

During the last year, I have combined my role of Company Secretary with providing the services of the Secretariat and assistance to the Board of Directors.

The President's Report has identified the election and appointment of Directors and their responsibilities for APEN's five Board Committees. As volunteers, our Directors have met their fiduciary duties to ensure good governance is delivered through drafting and reviewing a range of policies and guidelines. Discussion in the five committees provides ideas to keep APEN moving forward.

The inception of Covid-19 affected APEN's normal schedule of conferences. The conference was moved from one planned for October/November 2021 in New Zealand to a hybrid conference (planned in-person and online participation) in February 2022. The 2022 APEN International Conference Committee was launched in March 2021 with Prof Ruth

Nettle as Conference Convenor, APEN President Dr Anthony Kachenko as co-chair and with three other Directors along with a number of APEN members and some non-members as part of the committee.

All the Board and Committee meetings have been held via Zoom web conferencing. I sit ex officio on all these committees, working with the committee chairs on the agenda and recording the minutes. It gives a thorough knowledge and understanding of our core business.

Attendance at Board Meetings: The Board has met on twelve occasions since the last AGM, via web conferencing.

I know that APEN will continue to highlight the importance and value of being a change agent in the world of extensionists under a very professional leadership team.

I wish to acknowledge the assistance and support I have received from the Directors, and particularly Dr Pat Hamilton, during the last twelve months.

Governance and Strategy Committee Report

The Governance and Strategy Committee (G&SC) continues to provide oversight of the Board's governance framework and supports the ongoing review of APEN's strategic directions.

Governance Framework This year has seen a focus on policy review and development to ensure that APEN has the necessary policies in place to ensure the overall direction, effectiveness, management, and accountability of APEN. Several policies have been reviewed through the year, with a schedule established that will carry forward to ensuing years.

Risk Appetite Policy The G&SC has prepared a Risk Appetite Statement for APEN. Responsibility for risk management starts with the APEN Board and this statement details the amount and type of risk that APEN is willing to take in order to meet its strategic objectives. The statement will be used to inform APENS's risk management systems, policies and procedures and the Board's strategic decision making.

Board Charter The G&SC has commenced work on a Board Charter. A board charter is a policy document that clearly defines the respective roles, responsibilities, and authorities of the board of directors (both individually and collectively) and management in setting the direction, the management, and the control of the organisation.

Audit. Risk, Financial Control Report

The Committee met virtually three time during the year and addressed a range of matter. The following are items of note addressed in the year 2020-21:

• The Committee maintained an active watching brief of APEN's finances and provided regular updates to the Board.

- This included drafting an annual budget and a quarterly review of income verses expenditure.
- The Committee prepared a projected end of financial year retained funds figured through to 2024 based on a range of income and expenditure balances. These projections supported all Board members being fully aware of our financial status and meeting the Board's fiduciary responsibilities.
- The Committee identified several cost savings for the organisation, and they have been enacted.
- Advice was provided to the 2022 APEN Conference Committee on the need for a level of budget surplus that is required to underpin APEN's financial sustainability.
- An APEN donations and bequests Board discussion paper was developed. The Board adopted a number of recommendations and there is now a facility on our Web site to make donations and enquire about bequests.
- A Company Secretary succession plan was developed which documented current administration duties and identified critical administration functions.
- The Committee has been providing guidance to Dr Roe Currie (Company Secretary) in the review of APEN's hard copy records and stored publications. Roe has undertaken a stock take. Redundant and out of date (statutory limitations) records have now been appropriately disposed of.

As Chair of the APEN Audit, Risk and Financial Control Committee, I would like to sincerely thank members for the active contributions during the past 12 months and particularly Roe for her support and professionalism. Finally, the Committee would welcome additional members who would be willing to share a little of their time and expertise to support this committee. It would be an opportunity to grow your knowledge and understanding of not-for-profit board governance and finance.

Business Development Report

The Business Development Committee (BDC) continues to provide professional development and educational opportunities for members, while seeking new and creative ways to build our business. **Conference** After the uncertainty caused by COVID-19 an Expression of Interest process for a modified APEN conference was undertaken. APEN's Board accepted a strong proposal from the University of Melbourne, and a two-day conference is planned for Melbourne in February 2022. The essence of the conference is the hub and spoke model built on a combination of:

- Face-to-face (F2F) at a central location (hub);
- Regional F2F hubs (the spokes locally organised gatherings across Australia and New Zealand); and
- Virtual online delivery for those who can't or are unable to travel due to restrictions.

The conference will provide an opportunity for members to network and exchange ideas and experiences, undertake professional development, and showcase research, development and extension. Planning is well underway for this conference, utilising both face-to-face and on-line technology, include a regional hub in New Zealand.

Covid 19 disrupted other APEN events, including APEN's session at the International Congress of Sociology (originally Cairns 2020, postponed to 2021, postponed to 2022).

Professional Membership – APEN-PM As part of our ongoing member development work, the BDC researched, developed, and operationalised a new membership structure. A change to the membership classifications allows for two types of ordinary members: full members and professional members (APEN-PM). The APEN-PM membership is linked to qualifications and experience, a commitment to ongoing professional development, and adherence to ethical and accountable professional behaviour. The new APEN register, accessible by employers and funders, provides exposure of APEN-PM members' high level of skills, knowledge, and experience. The development and operationalisation of the new APEN-PM structure is the culmination of over two years of consultation and research undertaken by the BDC.

Value Proposition Raising APEN's profile with government, employers, industries and the extension community, APEN-PM will recognise and value the extension work carried out by our members.

Stakeholder Engagement Report

The Stakeholder Engagement Committee (SEC) is charged with ensuring the needs and expectations of internal and external stakeholders are clearly identified and understood. Our aim is to ensure APEN will be better placed to deliver an appropriate service to our members and to identify and respond to relevant opportunities within the extension sector.

During the past year, the committee has met four times to plan our stakeholder engagement activities and evaluate impact.

The **APEN website** is the external face of our organisation. Quarterly evaluation of the site traffic and engagement shows around 100 to 200 users access the site weekly. Understandably, the majority of users are from Australia and New Zealand, although there are a significant proportion of users from the Asia and the Americas. We also see users from Africa and Europe. New visitors to the site account for 89 percent of visitations and around 300 per guarter are returning visitors. Not surprisingly, the APEN homepage receives the greatest number of visits (around 33 percent) with the About page and those related to the REIS journal, extension, our events, and professional development all highly accessed. The committee is intending further review of the website with the aim for a refresh - we are keen for additional volunteers to assist us in this task from amongst our members - if you are interested, please contact Roe Currie on info@apen.org.au to register your interest.

Communication with members has been a priority with four editions of *ExtensionNet* in the past year, thanks to the excellent editorial team of Pat Hamilton, Chrissy Stokes, Adrian Englefield, Morag Anderson, and Roe Currie. There has also been 12 APEN *eBulletins* distributed to members this year - thanks Roe Currie for keeping as up to date with extension activities and opportunities.

We have also co-ordinated the delivery of five APEN webinars

- Designing Extension Programming for Impact with the eXtension Foundation's Impact Collaborative in the U.S. Cooperative Extension Service – the eXtension Foundation team (17 Aug 2020)
- Nebraska Extension Wellness in Tough Times Project The Wellness in Tough Times Nebraska team (23 Oct 2020)
- Understanding farmer decision making Prof Geoff Cockfield, USQ (15 Feb 2021)

- Queensland Extension Model of Practice Angela Williams, Canegrowers (19 Apr 2021)
- Understanding farmer decision making with behavioural economics, Dr Roy Murray-Prior, Agribiz RD&E Services (21 Jun 2021)

We appreciate the time taken by our presenters to deliver these webinars. If you missed out attending any recordings of these can be accessed via the Resources area of the APEN website.

The *Rural Extension and Innovation Systems Journal (REIJ)* was published once this year. Thanks goes to the editor Roy Murray-Prior and assistant editors Denise Bewsell and Lydia Turner for their work in producing such an excellent set of peer-reviewed and practice papers. We also thank the Editorial Board members who provide review of the papers during development. It is important that extension research and practice are published more broadly – as an extensionist please give thought to contributing to future editions of the journal.

We have attempted to actively use **social media platforms** in the last year to communicate with our members and the broader community - Facebook (63 posts) and Twitter (21 posts) were used. LinkedIn was not extensively used although plans are being implemented to improve this. More use of social media is needed but this requires members to use these platforms and tag #APEN – if you would be interested in assisting us in this way, please let Roe Currie know (via e-mail at info@apen.org.au).



Once again Jeanette Gellard and Roe Currie have facilitated the APEN Mentoring program with seven pairs of mentormentees. Thank you to all those who have participated in this program this year.

The Stakeholder Engagement team would like to thank all who have assisted with our activities in the past year, and we look forward to working with you again in 2021-22.
