I am delighted to present the President's Report for the 2021/2022 year.

APEN made several changes during the year to set itself up for future success. First and foremost, we farewelled Dr Rosemary Currie, who, after almost 27 years, retired from the Executive Secretary role from APEN. Roe was awarded an Honorary Life membership at the APEN International Conference in February 2022.

In May 2022, the APEN Board appointed the Association Specialists to manage APEN and provide support to the Board regarding governance, administration and membership support.



In May, we engaged Alice Long as a Communications Coordinator to support the Board and Stakeholder Engagement committee lift the profile of APEN through our communication channels. This decision has been long coming to ensure the organization have a strong presence and profile the great work of extensionists and the extension profession.

The APEN International Conference was a success – our biggest ever with 282 registrations. Although it was entirely virtual, thanks to cCOVID uncertainty, we connected virtually, shared, learned and challenged each other. Planning is underway for the next 'face to face' conference in 2023 – watch this space.

We also received a Grant from Building Better Regions Fund - Community Investments Stream. This grant will support the APEN Regional Coordinators working in extension in growing their capacity, capabilities, resilience to step up their leadership and support roles in their rural, remote and regional community.

We called for an EOI to deliver the 7-month online and face-to-face program and for 10 emerging leaders to join our nine Regional Coordinators as participants. We were overwhelmed by the large number of worthy applications – an indication that we are filling a strong need.

Treasurer's Report 06

Based on the audit of APEN by Bob Travers & Associates of Albury, NSW, APEN Ltd is in an improved financial position following the conference with a retained surplus of \$198,542 as at 20th June 2022.

This was largely due to an Operating surplus of \$94,430, largely due to income from the Biennial Conference held online in February 2022.

Thanks are due to Professor Ruth Nettle of Melbourne University and her conference team and the conference managers, JT Production Management.

Apart from the conference, major sources of income were from membership fees, pre-conference workshops, the ExtensionChat workshops and mentoring activities.

These additional activities over the last couple of years have broadened our income sources and provided additional services to our members.

The Audit, Risk and Finance Committee has developed policies and KPI's to manage risks and ensure our financial viability including:

- projecting financial position three financial years into the future,
- not starting a financial year with less the \$50k in reserves,
- budgeting for positive net cash flow over a two-year cycle,
- increasing membership, and
- developing recommended surplus amounts for conferences and events
