

Demonstrating the Value of Extension

The State Extension Leaders Network (SELN) has recently published a new booklet that demonstrates the contribution extension can play to making a difference in rural communities. Entitled "Extension works: case studies demonstrating how extension enables change in rural Australia", the 18 page booklet outlines several short stories from across Australia which provide examples of how modern extension methodologies have been utilised in achieving real outcomes.

The case studies describe real situations where a range of different communication methods have been used for varying objectives such as coping with drought, recovery after bushfires, promoting efficient fertiliser use, managing plant disease, and improving leadership skills. The stories, beautifully illustrated, highlight how extension made a difference in the outcome.

The booklet joins two other publications produced by SELN in the last few years.

One is a 12 page discussion paper 'Enabling change in rural and regional Australia', which describes extension as a policy instrument and defines it as "the process of enabling change in individuals, communities and industries involved in the primary industry sector and with natural resource management". The other is a two page summary describing extension.

The State Extension Leaders Network (SELN) is a gathering of government extension leaders and influencers from each state and territory of Australia. One of its objectives is to encourage key stakeholders to better understand the role extension can play and utilise it in meeting targets across a range of initiatives, particularly where practice change is the underpinning goal.

APEN President's Report for 2007/08

Due to competing work priorities, which often take me overseas I have decided not to stand for another three year term as APEN President. However, I am looking forward to remaining part of the MC as Past President. This does mean that current Past President John James will be leaving the MC. John has been involved as Committee member, President and Past President over many years. I have greatly appreciated his input and also that of the other members of the Management Committee during my term as President.

It was with sadness that we accepted Amabel Fulton's resignation earlier in the year. She resigned as APEN Secretary and Tasmanian Regional Coordinator for medical reasons. We thank Amabel for her input to APEN, working with APEN for the 2003 National Forum and the Youth Leadership series in 2005, as well as her terms on the Management Committee both in 2006/2008 and her earlier stint in the late 1990's when she was also on the organising committee of APEN's First International Conference. We look forward to having Amabel as a member, in a less strenuous role, for the continuing future.

Greg Owens has left his job in the Northern Territory Department of Primary Industry Fisheries and Mines to return to high school teaching. We thank him for his five years on the APEN MC and wish him well in shaping future leaders.

The major APEN event over the last twelve months was the National Forum held in Canberra in November last year. This was quite different to normal APEN events. It was an attempt to have a Forum where authors presented articles or chapters that were to be part of an Extension Publication. Many members were involved in the process and we also gained new members in those who attended and the relationships developed with Greening Australia and CSIRO.

We look forward to launching the hard copy Australasian Extension Publication at our next International Conference to be held in Busselton, WA from Monday 9th to Thursday 12th November, 2009.

The theme of the 2009 International APEN Conference is "Shaping Change in Communities; Dimensions of Excellence" and as well as agricultural and natural

resource management professionals hopes to include many other professionals involved in rural and regional communities. The Department of Agriculture and Food, WA is the main sponsor for this event which is being ably organised by WAAPEN members lead by Tracey Gianatti and Pamela l'Anson.

Our eBulletin has been sent to all of our members on a monthly basis keeping them up to date with extension activities and issues. Any articles of interest or positions vacant should be sent to the Secretariat by the 2nd of each month to go in that month's eBulletin. The eBulletin was used along with a hard copy in the membership subscription mailout and in ExtensionNet to tell members about the APEN Roadshow planning and to get them to do a survey about their preferences for topics to cover and locations of workshops. Because we were not successful in getting funding to run the Roadshow we have decided to do it on a cost recovery basis. Registrations will be done through the APEN Website. A local member, perhaps a Cluster Coordinator or Regional Coordinator, will assist Roe Currie in organising the venue for the workshop in each region it is held around Australia. Please keep your eye on the eBulletin for more details for this event which will be held in late February, early March next year.

Regional activities

Regional Coordinators on the Management Committee allow us to hear about things happening around the APEN Regions (the seven states of Australia and NZ/ Overseas).

Although there has not been much APEN activity occurring in some of our Regions over the last twelve months, we congratulation those who have organised and supported these events. These events include:

- The WA Region held a workshop run by Ian Plowman on Behaviour and Innovation. There were 18 participants at the workshop held in July.
- The NSW Regional coordinator and cluster coordinators who were very busy working towards the APEN 2007 National Forum and the Australasian Extension Publication.

• In NZ, APEN members at the Grasslands conference held in October took the opportunity to network.



Activities have both member and nonmember presenters and participants. They provide valuable networking and professional development opportunities. Our intention is that all members will have more opportunity to be involved in such activities, and encourage more clusters to meet within regions and interest group clusters to meet over the Internet in email discussion groups.

Although we have a number of Cluster Coordinators, some Regions do not have a representative and therefore the level of local activity has not been as great as we would have liked.

Other activities

ExtensionNet had three issues in the last financial year with Dr Christine King as Editor, being on maternity leave. Roe with great assistance from John James were able to achieve the completion of these issues in Chrissy's place. As always, the Editor would appreciate any contributions from members for ExtensionNet.

APEN continues to work collaboratively with the Australian Farm Business Management Network to produce an **Extension Farming Systems** journal and I would especially like to thank Neels Botha and Roy Murray-Prior for their continuing efforts.

The Management Committee has met by teleconference every second month to progress a range of issues, all under the umbrella of the Business plan. I'd like to take this opportunity to thank each of the members... John James (Past President), Jess Jennings (Vice-president, Treasurer & NSW RC), Amabel Fulton (Secretary & Tasmanian regional coordinator (RC)) Chrissy King (Editor), Derek Foster (Qld RC), Alison Medhurst (Vic RC), Greg Owens (NT RC), Tracey Gianatti (WA RC), Neels Botha (NZ RC) and Ceris Crosby (SA RC). I would also like to sincerely thank Rosemary Currie, our Secretariat, for her efforts for APEN this year.

APEN President's Report for 2007/08 Continued

As a matter of accountability, Table 1 details the meetings we held and the participants at each.

Arising from the 2007 Forum in Canberra were possible partnerships with Greening Australia, the National Landcare organisations and CSIRO. These partnerships were in terms of informing members of activities happening in our separate organisations with the possibility of joint activity. We have informally achieved this through our eBulletin going to members who are also members of the other organisations and in our publicising the Greening Australia conference in the eBulletin. No formal partnerships have been formed at this stage.

APEN was represented at the National Rural Women's Summit by Cynthia Mahoney (Vic). The summit title was 'Strengthening the Voice of Rural Women'. Two of the main recommendations were a Declaration on Water, a major issue in Australia, and that 50% of the membership of all boards should be women. In APEN's case we went close to that recommendation with 5/11 or 45.5% being women. There were 84 recommendations in all from the summit. We are organising a link from our website to the report from the Summit. Thanks Cynth for representing APEN at this important event.

APEN has continued to be represented at the State Extension Leaders Network meetings by myself and John James and other members who are also part of SELN.

We sought comment from members through the eBulletin on whether APEN needed to have

a position on Climate Change that could be included as part of the Strategic Plan or as a separate policy statement. The responses from members became an article in the September issue of ExtensionNet and the main conclusion was that APEN needs to recognise the changing environment and determine what we can provide in terms of support for members rather than having a policy statement, as such, on global warming.

We were pleased to launch the Members' Page on the APEN website earlier this year. To access the page you need to enter the email address you have in the APEN database and your membership number. Suggestions on content are always welcome.

Conclusion

As a private business consultant / manager this year has been extremely active for me both here and internationally, making attendance at all MC teleconferences difficult. This situation is continuing this week which is why my VP Jess will present this report as I have commitments in Taiwan, China, Macau and Hong Kong. I would like to personally thank Jess who has done a great job chairing the meetings when I was not available.

I encourage members to get behind your new President, to interact at the local level as well as through the email system and look ahead to the APEN Roadshow in February March 2009 as well as further ahead to the next International Conference in Western Australia in November 2009.

APEN Treasurer's Report for 2007/08

Jess Jennings, Treasurer

This report is based upon an audit of APEN's finances conducted by Bob Travers & Associates, Chartered Accountant, Albury, NSW.

The APEN financial position at June 30, 2008 is sound with total equity of \$99 264. This includes the support from Dept Agriculture and Food, WA for the 2009 International Conference. Therefore, APEN 's operating surplus for the 2007/2008 financial year was \$64 046. Without the \$50 000 support for the Conference the surplus would have been \$14 046..

Tables 1 and 2 record the profit and loss situation and Table 3, the Assets and Liability situation.

APEN is dependent on conferences generating a surplus of around \$20,000 and forums \$10,000. The surplus is from sponsorship deals and registration income. This is shown in Table 2 where figures show that the larger surpluses indicate a year with an International conference, a smaller surplus the year with a National forum and years with losses indicate that no national event was held.

A healthy surplus allows APEN to underwrite future conferences and forums as well as cluster activities.

As predicted last year, the sponsorship received for the APEN 2007 Forum enabled it to make a significant surplus to assist in APEN's operation. The surplus stands at about \$20,000 and income from the Australasian Extension Publication, which will be launched next year, will be ongoing.

As with any Association, finances are a constant issue for the Management Committee to deal with. We have invested money from the 2006 International Conference which was earmarked for assisting international participation (particularly from the Asia, Pacific regions). We increased the amount invested with the support from DAFWA for the 2009 Conference. That support money is already starting to be used in the organisation of that conference.

I look forward to a financially successful year this year in the lead up to the Conference next year.

Understanding Practice Change by Farmers

Adoption of new practices by farmers and other rural landholders was the focus of the recent Understanding Practice Change By Farmers symposium. The event was held in Melbourne on 14 November 2008, bringing together Australia's leading researchers and thinkers about practice change by rural landholders.

The symposium was motivated as a celebration of the success of a review paper on the subject jointly authored by six researchers, which has become the most downloaded paper of the Australian Journal of Experimental Agriculture (http://www.publish.csiro.au/nid/72/paper/EA05037.htm).

This highlights the importance of the issue of rural practice change, and the level of interest in it. The symposium aimed to provide insights into the current thinking about what drives practice change, when adoption of new practices is likely or unlikely, and what can be done to influence it. The discussions ranged from research evidence to practical application.

David Pannell, the symposium convener, conceived the event as a way of celebrating the success of the review paper. It was also a chance for the six authors to meet in person – some for the very first time!

A key outcome from the symposium was a realisation of the consistency of findings in practice change research across

all the disciplines involved: agricultural economics, rural sociology and social psychology. People might use different words, but they are really talking about the same things. It is also a very complex area and very difficult to generalise. At the heart, the circumstances of individual land managers need to be taken into account. As described in the paper by Pannell et al., 'Adoption depends on a range of personal, social, cultural and economic factors, as well as on characteristics of the innovation itself. Adoption occurs when the landholder perceives that the innovation in question will enhance the achievement of their personal goals'.

Interest in the symposium was remarkably strong. The original venue of 200 was almost immediately booked out, prompting a move to a larger venue to accommodate the 400 attendees.

The audience consisted of people working with land managers from diverse organisations including agricultural R&D agencies, catchment management authorities, non-government organisations and agencies involved in agricultural policy. Many APEN members were in attendance, looking to broaden their knowledge and skills

Symposium presenters came from a variety of disciplines (economics, rural sociology and social psychology) and were

well experienced in dealing with practical farming issues. Speakers included Dr Neil Barr, Andrew Campbell, Prof Allan Curtis, Geoff Kaine, Dr Rick Llewellyn, Dr Graham Marshall, Prof David Pannell, Roger Wilkinson and Prof Frank Vanclay.

In order to make the symposium material available to as wide an audience as possible, PowerPoint presentations, full audio podcasts, and an edited video of each presentation will be available at www.ruralpracticechange.org. The complete video footage of talks will also be available shortly for downloading or may be purchased on a DVD. Biographies of presenters with links to their recent publications can also be accessed and the organisers plan to publish a book, with chapters authored by each of the speakers from the symposium.

There are plans to hold a condensed version of the symposium in Western Australia in 2009 – APEN members, keep your eyes peeled for notices.

The symposium was available free of charge, thanks to generous sponsorship from the Victorian Department of Primary Industries, Future Farm Industries CRC, University of Melbourne, RIRDC, University of Western Australia and Landmark.
